DIVERSEcity is an award-winning multi-service registered charity governed by a dedicated Board of Directors.

We began our story in the City of Surrey, now the second-largest city in British Columbia with a population nearing 600,000. Working in collaboration with community partners, we now offer services in multiple regions across the province.

Thank you for your consideration to be part of the volunteer DIVERSEcity Board of Directors and related committees. It is an exciting time for DIVERSEcity; we are pioneering to be bold leaders in our field and are looking for directors who share our vision. We have announced our commitment to be an organization that supports progress toward anti-racism, equity, sustainability and Indigenous reconciliation in conjunction with our work assisting newcomers and other diverse communities.

The role of the DIVERSEcity Board of Directors is one of oversight and governance. Board officers are assigned responsibility for certain areas, but the Board carries out its responsibilities with one voice. We ensure that our activities and decisions are in alignment with the values and priorities, in accordance with our strategic plan.

As a prospective director, it is important to consider the time commitment expected. Board meetings, Finance and Audit Committee and Governance Committee meetings are convened on the same day bimonthly. Meetings typically occur on the first Wednesday of every other month with no meetings in July and August. Human Resources Committee, Risk Management Committee and DIVERSEcity Foundation meetings occur four times a year with the latter occurring on the same day as a Board meeting for the Society. Currently under our governance model, all Board Directors of DIVER-SEcity Community Resources Society automatically become Board Directors of DIVERSEcity Foundation as well. The purpose of the Foundation is to hold DIVERSEcity's real estate assets and provide space for operations to the Society.

All board and committee meetings are convened via Zoom video conferencing with the exception of two in-person meetings (one for professional development and the Annual General Meeting). DIVERSEcity's Annual General Meeting is scheduled in September each year. It consists of the necessary business matters including the election of directors, followed by a Board meeting for the election of officers for the subsequent year, and a public portion that includes our Awards of Impact.

- Attend AGM if nominated
- Sign the Code of Conduct Agreement, Confidentiality Agreement and Consent to Act
- Attend orientation session with the CEO
